COVID-19 VACCINATION PROGRAM

Dear Residents and Families,

The Australian Government has advised all aged care providers across the country that the COVID-19 vaccination program for aged care residents will be commencing this week. We have not yet been advised when the vaccinations will be available for Killarney Court & Lake Haven Court but we are anticipating that this will occur in the next couple of weeks. In order to be prepared for the vaccination date the government has provided a range of resources to assist residents and their families to make an informed decision regarding the COVID-19 vaccination.
